

NITNC Meeting Minutes 10 – 10 – 2017

Terry Deno opened the meeting at 7:00 p. m. 35 attendees  
The Morningside case is still in the Appellate Court. No new information.  
Barnes Road is aimed to be completed by Oct. 27th.

Jeanine McKinney reported a balance of \$6,784.67 in the account. The 2nd collection at the last meeting totaled \$123. This will go to the P.O.P. church towards extra funding for the Summer Concert Series in the park.

Mel Neil gave the report for the Community Assembly.

Some of the \$500 Grant money we received was used to purchase 2 Banners that can be displayed outside to advertise our meetings at the church and at the park during the concerts. There will be a Neighborhood Forum held on Oct. 17 from 6-8 p.m. at the West Central Community Center. The topic will be Sex Offenders in our Community. Moderator will be Melissa Luck, KXLY.

Officer Doug Strohsal said that there have been no reported crimes in our neighborhood lately. Terry reminded everyone of the Neighborhood Clean Up on Oct. 17th. All items must be in boxes or bags. Nothing over 25#. No garbage carts will be accepted. Items need to be out to the curb by 6 a.m.

Candace Mumm reported there is still some discussion regarding the speed limit for the new Barnes Rd.

It was designed for 30 mph but considering the steep grade and curves, 25 mph might be better. The Mayor's Office and City Council have been working together to develop a Strategic Plan to set goals and priorities for the City. The 3 priorities will be school routes (buses and walking), STA stops and routes, and medical facilities.

Terry mentioned that parts are still on order for the slide at Pacific Park. It may be ready by next Spring.
