Nov. 13, 2018 Meeting Minute

NITNC Meeting Minutes November 13, 2018 31 Attendees

Terry Deno opened the meeting at 7:00 p.m.

The current NITNC Website will be ending January 1, 2019. We are looking into finding a new one to replace it.

The Fall Curbside Pickup was a success. Twenty- seven tons of trash were hauled away. We used \$7,068 of our allotted \$7,500. We didn't go over our allotment, so we can have another pickup in the Fall.

Whipple Consulting Engineers will conduct a community meeting at Prince of Peace Church at 6 PM on November 27th to discuss the proposal for a Preliminary Long Plat for 138 new single-family lots. This meeting will also include a Traffic Study Scoping. The property is located North of the intersection of Wieber Drive and Navaho Drive. There will be a presentation and discussion at our NITNC meeting on February 12, 2019 concerning the request for a comprehensive Plan land use designation change and zone reclassification on a 25-acre parcel of land adjacent to the old landfill owned by the Douglas family. The request is to construct a mini-storage facility on the property.

Jeanine McKinney reported a balance of \$7,260.48 in the account.

Mark Davies gave a report from the Community Assembly Meeting:

The Plan Commission will hold a public hearing Wednesday, November 14, at 4p.m. on proposed text amendments to the Development Code. It will be at Spokane City Hall— Council Chambers.

Grant Funds are available for \$500-\$1,000 off the purchase and installation of a new wood, gas or pellet stove, or a mini-split ductless heat pump. Contact Spokane Regional Clean Air Agency for details and application forms.

Snow season is fast approaching. An emphasis is under way to get recreational vehicles, boats, and trailers off the street parking and into an appropriate winter storage location. After November 15th they are subject to being towed.

Doug Strohsal reported that crime activity in the neighborhood has decreased this past month.

Kitara Johnson gave a presentation on the changes happening at Excelsior. They have been working on developing an Arboretum for the Community to enjoy. They have planted 65 species of trees and they will have trails for walking.

A new Integrative Care Facility is being built on the site. It is intended to be available for youths that reach age 18 and choose to remain there up to age 21.

Excelsior has been approved for a Vocational School, and they now have a Health Clinic. They also contract with Spokane Public Schools.

Heather Trautman gave an update on the City Snow Plan. Snow season runs from Nov 15—March15.

All recreational vehicles, boats, and trailers must be off the street parking by November 15.

New equipment has been purchased (snow gates) –16 gates this year, up from 7 gates last year.

These should help reduce berms created from the plows.

Terry closed the meeting at 8:05 p.m
