Terry Deno opened the meeting at 7:00 p.m.

He announced that the Neighborhood Council is seeking to apply for a grant offered by the City of Spokane to help fund the July 10th Concert at the Prince of Peace Church again this summer. The grant is offered through the 2019 Community Engagement Grant Program and would be for \$650. An allotment of an additional \$300 could be made available if there are funds left over. A vote was taken to apply for the Grant. All attendees present voted in favor of the application.

Terry reminded everyone of the Curbside Pick-up on April 16, 2019. Watch for postcards coming in April.

Christopher Savage will be speaking at our next meeting on April 9, 2019. He is a candidate for a City Council position.

June 22 is the date for the North Indian Trail Yard Sale.

Jeanine reported a balance of \$7,129.72 in the account.

The new Neighborhood Resource Officer was introduced to the group. His name is Keith Cler. He welcomes questions at our meetings.

Mark Davies gave an update from the Community Assembly.

City Council Updates: Councilmember Breean Beggs, District 2

- I. Library School Bond -projects are getting underway, expanding options for all.
- II. Taxpayers approved Prop 1 for public safety, some of this funding will be used for pairing Social Workers with Police Officers.
- III. Parking study coming to an end. City Council will review the recommendations.
- IV. Coming back in May will be the bike share and scooters. You will not be allowed to ride your scooter on sidewalks in the downtown area.
- V. Council member Beggs has been working on a new partnership with Spokane COPS in identifying broken sidewalks and other obstructions for preferred routes to school and reporting them to Code Enforcement.
- VI. Speed zone resolution coming to City Council on Monday (yesterday) to address Speed zones around schools and parks.
- VII. Discussions around parking limit changes are happening with City Council now.

VIII. Gonzaga Leadership Program: Gonzaga is interested in this work with the neighborhoods, more details coming soon.

Karen Stratton reported that the City Council rejected the application for the zoning change for the lot next to the old landfill on Indian Trail Road. The vote was rejected 7-0.

The request for a boundary change for N. Upper Mayes Lane was approved. It is now designated to be in the Five Mile Neighborhood.

The City Council is working on measures to better control the speed around school zones and parks.

The Lime Bike Program will be returning this Spring.
