Terry announced that the Boy Scouts troop 171 annual spaghetti dinner will be March 7th from 6 to 8 PM at Assumption Church 3624 W. Indian Trail. \$15.00 for a family.

Mel Neil reminded everyone that we still need someone to manage the Yard Sale this spring. If no one volunteers then we will not be able to have one this year.

Terry said that we will have a spring curbside cleanup. That event usually occurs in April.

We are applying for a Hawk Crosswalk System and a Solar Powered Speed Information Signs in front of the Shopping Center. Also a crosswalk at Barns and Farmdale has been approved.

Terry asked the group for a vote on the application for the above application. The vote was unanimous in favor of applying for the grant.

Mark Davies presented the Community Assembly Report

Comprehensive Plan Training:

City of Spokane Planning Services is sponsoring a training for neighborhoods interested in the City's Annual Comprehensive Plan Amendment process. Topics include: what is the Comprehensive Plan, how to engage and comment on proposed changes, and important milestones for the yearly review and approval process.

When: Thursday, Feb. 13 (6:00-7:00pm)

Where: West Central Community Center- Newton Lounge (1603 N Belt)

What: Spokane residents can come learn why amending the Comprehensive Plan is important to them, and how the annual process to amend the Comprehensive Plan works.

Mobile Speed Trailors:

The Office of Neighborhood Services will ask the Neighborhood Councils for locations and dates, due by April 1.

Traffic Calming and School Safety:

The 2020 Traffic Calming and School Safety form asks for your neighborhood's 1st priority issue, 2nd priority issue (if you have one), and then any other issues you have identified in your neighborhood. Rather than project proposals, this form is collecting information on the issues your neighborhood would like to be resolved.

Clean-Up Program:

The Clean-Up Program Training will take place on Thursday, February 27th from 6:00-7:00PM in the City Hall Briefing Center (Lower Level). Every neighborhood wishing to participate in the 2020 Clean-Up Program must submit an application by the March 25th deadline. Applications will be accepted starting February 28th.

Officer Keith Cler presented the crime report. He told us that there last month was slow with 23 calls for service. There were 2 vehicle prowlings and 2 accidents. He reminded everyone to make sure their garage doors are closed. Also don't leave garage door openers in cars parked outside.

Candice Mumm presented news from the City Council. The city is looking for a police precinct location in the city core. She reported that homeless shelters in the city are working. Middle and elementary schools are planned on 5-mile in the Mead School District. The city is applying to the state for \$75,000 to help fund the Meadow Glen park at the north side of our neighborhood. She mentioned that communities can a committee to help design the park.

George Trey did a presentation on the current status of city's efforts to keep stormwater from entering the river. There is a lot of information about this at the city's internet sites, for example
