There were 21 clean-up events that took place in April and May. The Dump Pass program is running out of money and the last day to get Dump Passes is this Friday June 16th.

Council President (CP) Beggs will be leaving his City Council seat in July for a Spokane County Superior Court appointment.

Nancy Perkins reported for the Cop Shop News.

A good way to help deter crime in a neighborhood is to start a Block Watch Program. Information is available at the Shadle Cop Shop. She encouraged anyone interested to volunteer at the shop. She announced that the Cop Shop is sponsoring 4 Neighborhood Park Concerts this summer too.

Annie Deasy introduced our new ONS Liaison for Indian Trail area, Pollyanne Birge.

The City is seeking input from the Neighborhoods on Traffic Calming Projects. There will be a Virtual Workshop held June 16-23 to discuss ideas.

Karen Stratton gave an update from the City Council. She stressed that there is Power in the Neighborhood Councils. It is important to e-mail our City Council Representatives when there are issues that need to be addressed.

The Council recently approved money for the City and County from a settlement reached between the State of Washington and Opioid Distributors and Pharmacies that sold them. The money will be used for education and prevention.

Katie Kosanke , Spokane Urban Forester, spoke about the importance of healthy trees in our environment and their many benefits.

Lisa Woodward, from the Regional Clean Air Agency, spoke about the constant monitoring of the air quality by the Environmental Protection Agency. Fires are a main concern from July through September.

Randy McGlen is running for a position on the City Council for District 3. He spoke about his qualifications and ideas on how to address some of the issues the City faces.
